**The FALL 2007 Session (beginning Sep 7th, 2007) will center on the topic:**

## **" Ordo Salutis - Order of Salvation "**

The Friday night sessions will be taught by Pastor Eugene Cook using the book *Redemption: Accomplished and Applied* by John Murray and center on the order of the application of salvation. The New Testament teaches that the application of salvation is not one act. John Murray writes: "When we think of the application of redemption we must not think of it as one simple and indivisible act. It comprises a series of acts and processes. To mention some, we have calling, regeneration, justification, adoption, sanctification and glorification. These are all distinct, and not one of these can be defined in terms of the other. Each has its own distinct meaning, function, and purpose in the action and grace of God (Redemption: Accomplished and Applied by John Murray, p. 79, 80). These "series of acts and processes" follow an order in their application to the sinner. Historically, Reformed theologians have spoken of this as the "order of salvation" or ordo salutis. It is important to note that this order of salvation is a logical order and not a chronological one". **This principle is especially important in understanding the application of Christ's work of salvation to the elect of God. A proper understanding of the logical order of the application of salvation is vital to a right understanding of the gospel.**
